LETTER FROM THE EXECUTIVE DIRECTOR



Clubhouses provide a restorative environment for people whose lives have been severely disrupted by mental illness and who need the support of others who are also working towards recovery. Summit County Clubhouse is that healing and hopeful place in our local community. The challenges brought on by the worldwide pandemic inspired us to lean even harder into our work, ensuring that we were accessible to individuals with mental illness in Summit County. We learned that a crisis does not build character, it reveals it!

The character of Summit County Clubhouse is built on the Clubhouse model of cultivating hope and inspiring change to promote mental health recovery. During 2021, in the face of the ongoing COVID-19 crisis, our staff and members revealed their character by powerfully demonstrating that

with support, individuals with mental illness can and do lead productive, happy lives. Summit County Clubhouse:

- Ensured all Clubhouse members obtained or maintained safe, decent and affordable housing
- Ensured that NO Clubhouse members were hospitalized or incarcerated during the pandemic quarantine
- Supported 10 Clubhouse members in meaningful employment
- Recruited and sustained 19 Clubhouse members
- Provided 1736 hours of Clubhouse services to members
- Welcomed Clubhouse members by hosting special events and activities on all major holidays

Our staff, board of directors, and partners are bound by a commitment to promote personal and community wellness and empower individuals to achieve recovery. While most of us were still adapting to life in a pandemic, our board, staff, and generous supporters raised a record-breaking \$182,784 in 2021 to support our operations. These remarkable leaders also launched a \$294,230 cash and in-kind mini-capital campaign to renovate a new and permanent home for Summit County Clubhouse. Thanks to your support, Summit County Clubhouse is a POWERFUL FORCE FOR GOOD in our community.

During 2021, Summit County Clubhouse embarked on the *Future of Hope Building Campaign* to update, restore, renovate and upgrade the Highland Drive home—a literal transformation.

We envisioned a safe place of help and hope for people facing mental health challenges, where they can heal and thrive. 
